Dear New Resident:

Welcome to the City of Minnetonka Beach! The following information will be useful to you regarding some frequently asked questions of the City.

## **UTILITY BILLING:**

Your meter will be read quarterly by a remote system. The quarterly rates are as follows:

Water usage	\$13.40 per 1,000 gallons used
Lafayette Ridge water usage	\$9.09 per 1,000 gallons Orono
Sewer	\$160.00
Garbage	\$72.35
Garbage tax	\$7.05
Recycling	\$19.00
Leaf pickup	\$21.00
Annual water test fee	\$15.22 annual
Water base fee	\$38.00
Stormwater Utility	\$20.00
Water Treatment Plant Fee	\$335.00

The quarterly utility bills are mailed at the end of March, June, September and December. Payment is due 30 days from billing date. A 10% penalty on an unpaid balance is applied when payment is delinquent. Accounts that are delinquent for 90 days are subject to water shut off procedures. Electronic payments can be made on our website by clicking on the SERVICES tab and selecting bill category to pay. Fees apply.

## **PARKING:**

Parking permits are free to residents and available at City Hall. The permits are required to be affixed to your vehicle when using any of the parks and areas posted "Permit Parking Only." **Limit two permits** per household. Bring your vehicle license plate number(s) with you to City Hall to obtain permit.

## **DOCKS:**

The City of Minnetonka Beach operates a dock slip/lake access process for residents that do not live on the lake (non-riparian residents). The City does this through a multiple dock license with the Lake Minnetonka Conservation District (LMCD). The City has 80 dock slips available in varying sizes and locations around the City that residents apply for each year. Residents who have had a dock the previous year must still apply every year, but generally keep the same slip year over year unless their status changes or they wish to move to another open slip. The City only provides the lake access. Dock slip holders must provide their own dock and install and remove the dock at their own expense. **THE CITY PROHIBITS RESIDENT BOAT SLIP RENTALS TO OTHERS FOR BOTH PRIVATE AND CITY PERMIT DOCKS.**

The annual application process usually starts in February with City Staff sending out applications to residents who have had docks the prior year. New, non-riparian residents interested in a dock slip should contact the City Clerk at City Hall at any time in the process to see what might be available at that time.
